Remove Conditions on Criterion 3.d, 5.3.1.b, 5.5.1, and 6.1.3.

Place Condition on Overview 09: The business unit must routinely provide reliable information to the public on their performance, including student achievement. Describe how you routinely provide the following results to the public. **1. Student Learning Outcome Assessment Results:** Such as what you report in standard #4, ETS, MFT, accounting assessment, management assessment, critical thinking, communication, etc. **2. Program Results:** Such as what you report in standard #6, graduation rates, retention rates, job placement, etc. If you provide a link to aggregate business student results please ensure the link goes directly to the results such as this link:

Please ensure that all appropriate information is on the web site and include a link that works.

Place Condition on Standard 3: Although the table in the QAR was completed with four examples, each example only had a maximum of 1 or 2 data points and not the 3-4 data points needed to determine a trend.

The Conditions must be removed by 9/15/2018. Progress on the Conditions must be reported in future Quality Assurance Reports; it is not necessary to report on OFIs.

Your next quality assurance report will be due 9/15/2016 and your reaffirmation is scheduled for 2021.
